1. APOLOGIES

2. DECLARATIONS OF INTEREST

Cllr Holland-Delamere declared an interest in the Grant applications to the Councillors Community Fund from Rectory Farm Pocket Park and Shine Development CIC as the applications fall under his ward area. Cllr Holland-Delamere took no part in the deliberations of these two applications.

It was noted that the budget heading for the Councillors Community Fund was £75,000 (£3,000 per councillor) in the present financial year increasing to £4,200 per councillor for those who had opted not to take their allowance.
