k) CGF119 - Northants Knights Academy - £4,535.50

**RECOMMENDED:** It was recommended application CGF119 be declined, as the organisation was based outside of the Northampton Town Council boundary.

I) CGF120 - Ailsa's Aim - £4,000.00

**RECOMMENDED:** It was recommended application CGF120 be declined, as the Town Council was already supporting a charity completing similar work.

m) CGF121 - Project 16:15 - £10,000.00

**RECOMMENDED:** It was recommended application CGF121 be declined, as the organisation intends to use the funding to expand its services outside of the Northampton Town Council boundary.

		NN Nights was an initiative held across Northampton on August 16, 2024. Northampton Town Council funded the event's first instalment, supporting the development of an interactive website and establishing a micro-grant scheme for local artists to exhibit their work.		
CGF131	NN Contemporary Art - NNCA (legal name Northampton Arts Collective)	The event received positive feedback, but this new application requests support for a second event of the same format. The organisation hopes to hold these events quarterly; however, if they become dependent on NTC's funding to continue, the initiative may risk becoming unsustainable.		£5,000
		NN Nights aligns with the council's commitment to fostering a vibrant, creative town. It may be worthwhile to meet with the organisation to discuss ways to ensure more sustainable support moving forward.

		This project aims to preserve Northamptonshire's Black history archives by establishing a permanent, accessible home on Guildhall Road. Alongside this, it includes the creation of a digital platform and a local volunteer program focused on recruitment and upskilling. These efforts align with NTC's commitment to supporting local heritage.		
	Northamptonshire Black History Association	As part of a larger funding bid with the Heritage Lottery Fund, the project has been conditionally awarded £42,437, contingent on securing local match funding. Without the council's support, this grant—and the project itself—would be at risk.		£5,000
		Please note: The application specifies that NN Contemporary Art will serve as the designated account holder. The applicant explained that their organisation is currently transitioning bank accounts due to trustee changes. While they work to establish a		

		new account, NN Contemporary Art has agreed in writing to hold the funds responsibly on their behalf.	
CGF133		Dance Mind is an organisation specialising in work with adults facing mental or physical health challenges, particularly older adults. This project aims to continue their Dance Elders sessions at Delapré Abbey in 2025 and is part of a broader fundraising effort.	
	Dance mind	While the sessions take place outside NTC's boundary, residents of Northampton attend and benefit from them. I discussed the application with the applicant beforehand and clarified that NTC policy prohibits funding core costs. The costs in the application cover dance instructors, evaluation, travel expenses, and room hire—all of which may be considered core costs for the organisation. If NTC were to support this application, it could potentially cover room hire at £660.	£10,000
		Without the full funding requested for the Dance Elders	

		programme, the project will only be able to run for eight weeks in 2025, due to a smaller contribution from West Northamptonshire Council.	
CGF134	Gingerbread, the charity for single parent families	This is a national charity that provide support for single parent families. They have recently began delivering a monthly support group at Delapre Abbey. This is outside of NTC's boundary and the application doesn't state where people are travelling from to attend the sessions. The application also refers to the area as 'Nottingham'. This suggests the application isn't being made by a member of the Northampton Community. The costs on the application are for staff costs, volunteer expenses.	£3,000
CGF135	Restore Northampton	Restore are responsible for various food aid initiatives throughout the town and this is continue running their charity allotment. It's run by a team of volunteers and people are referred into this service from other organisations. The organisation has been awarded part funding from Northampton Community Foundation and the requested amount to continue delivering the allotment. The costs in the application are unclear	£9,982

	as it mentions team costs. The money requested will enable them to keep the project going for the next financial year.
